Important Information Regarding Rebates:

- ▶ To qualify for a rebate, the water heater must be installed at a service location receiving electricity from Sioux Valley Energy and used for a water heating application that allows a load management receiver to be installed. It must carry a lifetime warranty and be 50 gallon or larger capacity. The water heater must be purchased and rebate applied for by December 31, 2010.
- ▶ The member agrees to participate in the load management program for a minimum of five (5) years from the rebate date. If the receiver is removed prior to that date, the rebate amount will be billed to the account. The member will receive a \$6 monthly bill credit for participating in the load management program (requires a minimum total electric usage of 300 kWh per month).
- ▶ Rebates will be issued at \$3 per gallon for a water heater with 50-79 gallon capacity (credit applied to electric account) and \$6 per gallon for a water heater 80 gallons or larger (check issued). The rebates will be issued to property owners.
- ▶ Fill this form out completely. Return the rebate form when the water heater is installed (plumbed and wired). Incomplete forms will not be processed. Submit a copy of proof of purchase/sales receipt and verification of lifetime warranty for water heater. Documentation will not be returned.
