The student is responsible for submitting all materials on time. Incomplete applications will not be evaluated.

Checklist	1. Students who are planning to attend an accredited power line technical college this four-page application (attach additional sheets if necessary). Your name and addr be on all attachments. Completeness and neatness ensure your application will be evappropriately.				
		2. Copy of your recent academic transcript. To qualify for a power line technical college scholarship, you must have a high school cumulative grade average of at least a 2.5 on a 4.0 scale. Please ensure that no private health information is included in the transcript.			
	3. ACT and/or SAT exam scores are not required to be considered for a power line technic college scholarship.				
		4. Essay question – Why do you want to become a power line worker? Essays must be written utilizing original thought. Artificial intelligence (AI) applications, such as Chat GPT, are not allowed. If it is determined that an artificial intelligence assistance program is used to answer the question, your scholarship application will be disqualified. Essay MUST be typed (handwritten essays will not be accepted.)			
		5. Letter of Reference – Include a letter of reference from a teacher, school counselor, employer, youth leader, or pastor.			
		6. Application must be signed by either a parent or legal guardian for the student to be considered. The parent or guardian must be a Sioux Valley Energy member.
