The regular meeting of the Board of Directors of the Sioux Valley-Southwestern Electric Cooperative, Inc. (dba. Sioux Valley Energy) was held on April 23rd, 2018 commencing at 8:30 a.m. at the Colman.

The meeting was called to order by President Rodney DeMent who presided and Allan Kooima, Secretary, acted as Secretary.

REVIEW AND CONSIDERATION OF AGENDA

The agenda was presented. A motion to approve the agenda was made by Mr. Drost, seconded by Mr. Kooima. The motion carried.

REVIEW AND CONSIDERATION OF MINUTES

A motion to approve the minutes of the regular board meeting of March 20th, 2018 was made by Mr. Johnson, seconded by Mr. Daniel. The motion carried.

REVIEW AND CONSIDERATION OF THE LEWIS AND CLARK WAPA WHEELING RATE TARIFF

Manager McCarthy called upon Debra Biever to present the Lewis and Clark WAPA Wheeling Rate Tariff. A motion was made by Mr. Zylstra to approve the Lewis and Clark WAPA Wheeling Rate, seconded by Mr. Hansen. The motion carried.

REVIEW AND CONSIDERTAION OF THE CITY OF AURORA ANNEXATION AGREEMENT

Manager McCarthy called upon Ted Smith to present the City of Aurora Annexation Agreement. The City of Aurora notified us to annex the Spilde Second Addition consisting of 8.81 acres. We do not have any customers within this area. A motion was made by Mr. Weinacht to approve the City of Aurora Annexation Agreement, seconded by Mr. Drost. The motion carried.

Manager McCarthy and Attorney Peterson gave an update on the electric cooperative government task force report. They will keep the directors up to date on issues as they arise.

Manager McCarthy called upon Sharla Haugen to present the April Storm recap. Sharla shared statistics from the storm, along with some pictures and a video. Ted Smith shared the appreciation we had from the help of East River Electric, Karian Peterson, along with all of our Sioux Valley Energy employees.
